GENERAL INFORMATION

WHAT IS A "SHOW TEAM"?

Our Show Teams will perform in the Exhibition division at competitions this season! These are teams made up of beginning cheerleaders ages 3 to 6 years old, who will perform at each event rather than compete. Show team athletes wear a complete uniform similar to the competitive teams and gain good performance experience to prepare them for future cheerleading opportunities.

WHAT DO THEY LEARN?

The coaches focus on teaching each athlete the basic skills of cheerleading (jumps, motions, dance, tumbling and ground level stunts) They work on developing an athlete-like focus and dedicating their attention to one activity for an hour class. Half of their practice will be spent learning a choreographed 1 minute 30 second cheer routine that they will perform at competitions. The other half of practice will be geared towards learning new skills! It is AMAZING how much these athletes grow from beginning to end of the season. Most importantly, THEY HAVE FUN!

HOW DO I KNOW IF MY ATHLETE IS READY?

The most important factors WE consider for participation in our Show Team are:

- 1) Can they handle one hour of activity without a parent?
- 2) Can they use the bathroom by themselves?

HOW LONG IS THE SEASON?

- Practices will start the week of July 10th
- The season lasts from July 2023 - April 2024
- Performances are from November-March
- Skills training is March-April
- Tiny Boot Camp is May & June (OPTIONAL)

HOW OFTEN DO THEY PRACTICE?

The Show Teams will practice once a week for 1 hour.

PRACTICE WEAR

Practice wear can be purchased from the WE pro shop. Each team member is required to purchase the red cheetah practice wear. White low top tennis shoes will be required with their uniform. Shoes must be worn and hair must be out of face for practice.

PROGRAM RULES

Material Agreement

As a member of Woodlands Elite All-Star Cheerleading Program, any material (cheers, chants, pyramids, partner stunts, transitions, dances, music, routines, etc.) may not be used or taught for any purpose, to anyone outside the Woodlands Elite All-Star Cheerleading Program. All material is owned by Woodlands Elite Cheer Company, L.P. and may not be reproduced or taught in any manner without prior written consent from Woodlands Elite Cheer Company, L.P. Anyone violating this agreement may be expelled immediately from the Woodlands Elite All-Star Cheerleading Program.

Uniform Agreement

Any and all parts of the Woodlands Elite All-Star Cheerleading Program uniform may only be worn during specific and official Woodlands Elite All-Star Cheerleading Program activities. The uniform may not be worn for any other activity without prior written consent from Woodlands Elite Cheer Company, L.P. No part of the uniform may be loaned to any person that is not a current member of the program.

Property Rights Agreement

No Woodlands Elite Cheer Company, L.P. or Woodlands Elite All-Star Cheerleading Program related items may be sold without prior written consent from Woodlands Elite Cheer Company, L.P. The company name and its entity are solely owned by Woodlands Elite Cheer Company, L.P. Any violation of this agreement may result in legal action.

Outside Merchandise Sales Policy

No spirit wear of any kind may be designed, purchased, or distributed with a Woodlands Elite Logo or Team name. All team t-shirts and spirit items will only be purchased through pre-approved vendors by Woodlands Elite. This does not include snacks, cakes, cookies or consumable goodie bag items. No solicitation of any items while on Woodlands Elite property will be allowed.

Valuables In The Gym

It is not possible to monitor valuables brought into the Woodlands Elite facility. Please leave valuables at home or in the car. Woodlands Elite will not be responsible for any lost or stolen items. Please realize many items of jewelry, etc. come up missing in the gym every year. The best way to avoid this is to leave valuables at home or in the car. If you bring valuables into the gym you are doing so understanding the risk you are taking. Don't become a victim of lost valuables.

Practices

All team members are expected to attend EVERY practice. Once competition season arrives the coaches may call extra practices as necessary.

THERE ARE NO EXCUSED ABSENCES FROM A COMPETITION

Every team member is expected to attend every competition. Any athlete that misses a competition may be removed from the program. In rare instances some teams may be required to compete on a Friday afternoon/evening for a National Competition which may require some missed school time.
